Partners 3, 7, 11 and 14 are developing the European Common Mention for Teachers.


All partners are involved in the production and experimentation of the products and will ensure the dissemination and valorisation of the project after its completion.



Presentation of ELICIT Reference Framework at the Public Seminar


































